Motion to Accept the February 12, 2019, Board of Directors Meeting Minutes

A. ACC Report – Alan Lafever

i. Lot #53C Garage Door Replacement

The ACC Approved the Sethi's garage door replacement submittal. Ms. Hamblin will notify the Homeowners of the approval.

IV. Grounds & Safety Update - David Monroe

A. Landscape Design Bids

Mr. Monroe obtained bids to have a landscape architect draft a new design concept for the entrance though the first roundabout. After a discussion a motion was made to hire Shelly Abbott of Landscape Design West not to exceed \$4,500.00. The motion was seconded and approved by all.

B. Turf Project

The Committee has been viewing samples of turf to see which product would look the best among other qualities. It was agreed that the grass with the thatch mixed in was a favorite. Mr. Monroe is getting quotes to put in test patches of the turf with the idea

C. Border Fence

There are areas of the border fence that need repair due to openings. Mr. LaFever and Mr. Monroe will inspect the fence and Lexi will obtain bids to repair.

A discussion ensued regarding investment of Association funds. Mr. Cohn recommended keeping the accounts where they are for the time being. Perhaps in the future the accounts will be moved to Vanguard or Fidelity. A. Schedule of Fines

B. Mineral Buildup on Entry Walls

The walls around the grass areas north of the entrance drive have been stained with calcium buildup and it was decided that the irrigation heads that water the grass will be changed so that water is directed away from the walls. Once this is accomplished, then the Board will have the walls either cleaned or repainted.

A. Rural Metro Fire Protection

Ms. Hamblin brought an invoice from Rural Metro Fire Department to renew the fire protection of the building at the entrance (3131 E Ina Rd). The invoice will be paid.
