Provide, program and install (3) three outdoor 4-MP IP PoE License Plate capture camera (dual code H.264,MJEPG)to view inbound traffic at vendor, resident and exit lanes at main entry gate Provide, program and install (3) Three outdoor 4-MP IP PoE camera (dual code H.264,MJEPG).





(3) Three License Plate Capture POE IP Camera

(3) Three 4 MP Outdoor POE IP Camera

Provide (1) one PoE 60-watt managed 8-port switch to power cameras. Provide (1) one 8 Channel NVR with 4TB HDD for live view and stored playback. Provide (1) 24" monitor for live viewing and playback of cameras. Provide up to 500 ft outdoor Cat5e/6 cable for IP camera(s) connection to existing network. Provide materials conduit and housings where required.
