Some sidewalks have tripping hazards. Ms. Fleming will see if Ace asphalt has a concrete company to provide an estimate to replace and improve all sidewalks in Cobblestone that are necessary.

• Fountain and Rod Iron

Ms. Fleming will reach out to Wild West Painting to see if they can move forward on the painting project to include the rod iron and second fountain. The walls will still need to wait until the irrigation is repaired and will not damage the walls right after they have been repainted.

• Increase to Assessment

The Board reviewed and agreed to keep up with the cost of vendors an increase of \$100.00 should be added to the annual assessment.

Mr. LaFever moved to approve the \$100.00 assessment increase per year. \$50.00 per assessment period. Mr. Lackenbauer seconded the motion and was unanimously approved.
